# **ASQAs Decision to Reject Renewal of Registration**

Site Group International Limited's (ASX:SIT, "Site") Registered Training Organisation Site Skills Group Pty Ltd on Friday 20 April 2018 received from the Australian Skills Quality Authority ("ASQA," the "Regulator"), a rejection of renewal of registration notice (the "decision").

It is important to immediately note that there has been no suggestion or accusation of illegality against Site or its entities, and that the company has numerous review options available to it which it will immediately instigate. With Site Skills Group expected to contribute in excess of \$14m revenue for the group in FY18 via the delivery of approximately 25,000 accredited programs to our key industry partners, the group is focused on minimal impact to the operations of the business while the regulatory actions are finalised.

While at this stage this remains a procedural matter, with Site able to seek a review of the decision within ASQA or to immediately proceed to the Administrative Appeals Tribunal, for reasons outlined below Site has lost all confidence in the capacity of the Regulator to conduct itself impartially and to afford procedural fairness and natural justice.

Site would like to make it clear that, in five years of operation, Site Skills Group has delivered over 100,000 accredited programs to people with an excess of 80% employment rate, in the highest risk occupations and industries in Australia. Site Skills Group has been audited for the delivery, compliance and integrity of its accredited training and assessment programs by state and territory government departments and major industry clients.

As such, Site will commence all avenues legally available.
