- (i) On 12 October 2017, the Company entered into a loan facility agreement with Rey Resources Limited ("Rey") for the granting of \$1 million standby loan facility to Rey at an interest rate of 12% per annum and for a term of 1 year. The facility amount was subsequently increased to \$1.5 million pursuant to a Deed of Amendment dated 18 December 2017. On 2 March 2018, the Company agreed to further increase the facility to \$2 million and to extend the loan maturity date to 31 December 2019. As at 31 March 2018, a total of \$1.5 million had been drawn down by Rey.
- (ii) On 14 November 2017, the Company entered into a loan facility agreement with ActivEX Limited ("AIV") for the granting of \$1 million standby loan facility to AIV at an interest rate of 12% per annum and for a term of 1 year. A total of \$485,000 had been drawn down by AIV as at 31 March 2018.

- (c) Repayment – ASF may, at its sole discretion, repay the outstanding loan and interest by either one or combination of (i) the issue of shares in ASF's subsidiaries; or (ii) the transfer of securities held by ASF or its subsidiaries; or (iii) cash.
