

# 360 Capital Total Return Fund (TOT) Investment Update

360 Capital FM Limited as responsible entity for 360 Capital Total Return Fund (the Fund or TOT) is pleased to advise the Fund has provided a \$36.25 million senior loan facility for the construction of a 15-level, 162 room 4-star hotel in the Melbourne Central Business District.

This project presented a unique opportunity for the Fund to provide short-term funding on a high-quality project with construction substantially underway, de-risked and due for practical completion on or around November 2018.

A summary of the loan investment is provided below:

# **Capital Allocation**

Whilst capital allocation has been slower than forecast, the Fund has been focused on credit quality and project fundamentals rather than volume of transactions. The Fund has now committed approximately \$55.0 million to predominately first mortgage senior loans diversified across Australia and in various real estate sectors. The Fund has approximately \$24.0 million of available capital to invest into similar first and second mortgage loans.

## Guidance

The Fund reaffirms distribution guidance of 9.0 cents per security for FY18.
