# Evans & Partners Asia Fund – Admission and Commencement of Official Quotation

#### **Description**

On 23 March 2018, Asian Masters Fund Limited (the "Company") announced that it was convening a meeting to seek shareholder approval for resolutions that would facilitate the implementation of a restructure of the Company from a fund-of-funds, listed investment company to a new direct equities listed investment trust by replacing the Company with a newly established registered managed investment scheme, Evans & Partners Asia Fund (the "Fund") while retaining similar exposure to Asian markets (the "Restructure").

On 23 April 2018, the Company's shareholders approved amongst other things, the Restructure.

Under the Restructure, the Company's shareholders will receive one fully paid ordinary unit in the Fund for every ordinary fully paid share held in the Company on the Record Date.

On 14 May 2018, the Company confirmed that all the conditions of the Restructure had been satisfied.

The Fund was admitted to the official list of ASX Limited ("ASX") on Tuesday 15 May 2018.

Official quotation of the Fund's ordinary fully paid units is expected to commence at 11:00AM AEST on Thursday 17 May 2018.
