Bulletproof Shareholders Vote in Favour of Scheme of Arrangement

Friday, 18 May 2018: Bulletproof Group Limited (*Bulletproof*) (ASX: BPF) is pleased to announce that at the Scheme Meeting held today, Bulletproof shareholders approved by the requisite majorities the proposed scheme of arrangement under which Klikon Group Holdings Pty Ltd (*AC3*) will acquire all of the shares of Bulletproof (*Scheme*).

Voting results

The poll report submitted by the returning officer as appointed by Bulletproof is attached.

In summary, the resolution to approve the Scheme, as set out in the Notice of Scheme Meeting in Appendix 4 of the Scheme Booklet dated 10 April 2018 (*Scheme Resolution*), was passed by the requisite majorities of shareholders, with:

- 84.98% of Bulletproof shareholders present and voting (either in person or by proxy) in favour of the Scheme Resolution; and
- 98.66% of votes cast in favour of the Scheme Resolution.

These results exceed the majorities for the purposes of the Corporations Act 2001 (Cth).

Next steps

The Scheme remains subject to Court approval in order to be implemented. Bulletproof has applied to the Court for approval of the Scheme at a hearing currently scheduled to be held at 10:15am (Sydney time) on Friday, 25 May 2018 at the Federal Court of Australia, Law Courts Building, 184 Philip Street, Sydney NSW 2000.

If the Court approves the Scheme, Bulletproof shareholders will:

- receive A\$0.152 for each Bulletproof share they hold on the Record Date (currently proposed to be 7pm (Sydney time) on 1 June 2018) (**Scheme Consideration**); and
- be paid the Scheme Consideration on the Implementation Date, which is expected to be Wednesday, 6 June 2018,

in accordance with the terms of the Scheme.
