## **Oliver's Real Food Limited (ASX:OLI) – Request for Trading Halt**

Under ASX Listing Rule 17.1, Oliver's Real Food Limited (**Oliver's** or the **Company**) requests a trading halt in its securities, being ordinary shares (ASX code: OLI) from the commencement of trading on Monday, 21 May 2018.

In accordance with Listing Rule 17.1, we advise:

1. the trading halt is requested pending an announcement by Oliver's in relation to a trading update and revised earnings guidance for FY18;
2. Oliver's wishes the trading halt to remain in place until the earlier of such time as it makes an announcement to the market in relation to the trading update and revised earnings guidance or commencement of trade on Wednesday 23 May 2018; and
3. Oliver's is not aware of any reason why the trading halt should not be granted or of any other information necessary to inform the market or ASX about the trading halt.
