RCR AWARDED CAPITAL WORKS FRAMEWORK AGREEMENT AND MAINTENANCE CONTRACT

Diversified engineering and infrastructure company RCR Tomlinson Ltd (ASX: RCR), is pleased to announce that it has been awarded new Victorian Government contracts.

Melbourne Water Corporation, Water and Sewerage Capital Works Program

RCR, together with its joint venture partners Abergeldie Contractors Pty Ltd and Stantec Australia Pty Ltd, has executed an initial three (3) year Framework Agreement (plus possibility for extensions of up to a further seven (7) years) with Melbourne Water for its Water and Sewerage Capital Works Program.

The Framework Agreement qualifies RCR and its JV partners as preferred service providers for the program of works covering a range of design and construct, construct only, and design only projects. Melbourne Water have indicated that their Capital Works Program is worth approximately \$500 million over three (3) years and will be delivered between two panel members, one of which is RCR and its JV partners' Safety Focused Performance Joint Venture.
