Commentary

Operations

The Group received the proceeds from the issue of the convertible notes on 10th April (AU\$1,000,000).

On the Group's legal suit against Soar Labs Pte Ltd, as advised in the Group's ASX announcement on 24th May a settlement has been agreed.

The Group is making good progress on its Cryptocurrency exchange and has filed its application to AUSTRAC. Pre-registration is expected to start soon.
