The weekly estimated unaudited net asset value before withholding tax on unpaid distributions as at 8 June 2018 was \$1.57* per unit on a fully diluted basis.

The Fund is a long-term investor and does not intend to dispose of its total portfolio. If estimated tax at 21% on unrealised portfolio gains or losses were recognised, the weekly estimated unaudited post tax net asset value before withholding tax on unpaid distributions as at 8 June 2018 would be \$1.45* per unit on a fully diluted basis. These estimates may not take into account all intra-month accruals, which are incorporated in the monthly NTA updates.
