Outcome: passed

The resolution was decided by a show of hands. The total number of proxy votes exercisable by all proxies validly appointed was 31,846,606.

The total number of proxy votes in respect of which the appointments specified that:

- (a) the proxy was to vote for the resolution was 16,846,456;
- (b) the proxy was to vote against the resolution was 481;
- (c) the proxy was to abstain on the resolution was Nil and
- (d) the proxy could vote at the proxy's discretion was 14,999,669.
