This announcement replaces the prior dividend announcement issued by UBS dated 27 Jun 2018 following confirmation by SPDR MSCI Australia Select High Dividend Yield Fund of the finalised distribution and franking amounts

The Dividend amount will be paid to Holders as soon as reasonably practicable after receipt of the Dividend in cleared funds by UBS Nominees Pty Ltd, as Security Trustee, from SPDR MSCI Australia Select High Dividend Yield Fund (payment to Holders is expected to be made within 5 Business Days of the Security Trustee receiving the Dividend). The Security Trustee is expected to receive such funds on 11 Jul 2018, the Share Issuer's Dividend payment date.
