## Commentary

### Operations

The Group is progressing the development of its Cryptocurrency exchange. The Group's management team continues to be in discussions with banking institutions in relation to the provision of currency pairing facilities due to an earlier banking institution's change in policy regarding their pairing services. The third party Know Your Customer (KYC) interface has now been integrated and testing of the KYC functionality is underway. The Group has made its filing to AUSTRAC for registration. The Exchange launch date is dependent on the issuing of the AUSTRAC registration and implementing an appropriate pairing service.

BPG will continue to explore new and existing business opportunities for the wine distribution businesses in Asian markets, particularly with its 8 Eagles range.
