### COMPLETION OF SHARE CONSOLIDATION AND APPENDIX 3B

LWP Technologies Limited (ASX: LWP, “the Company”) is pleased to advise that it has completed the consolidation of its ordinary share capital by converting every seventy (70) existing fully paid ordinary shares (Shares) into one (1) Share (Consolidation).

The Consolidation was approved by shareholders at the Annual General Meeting of the Company held on 28 June 2018.

As a result of the Consolidation, the post-Consolidation Share structure of the Company is as follows:
