Amended Appendix 3Y - Late Lodgement Notice

Please find attached is an Amended Appendix 3Y *Change of Director's Interest Notice* for Dr. Andrew Stewart.

For the purposes of Listing Rule 18.7, Xanadu Mines Ltd (Xanadu) provides the following information:

- 1. The Appendix 3Y lodged on 18 May 2018 on behalf of Dr Stewart, did not include the acquisition of an additional 6,245 shares due to an administrative oversight by the Company. As soon as the oversight was identified today, the attached Appendix 3Y was lodged with the ASX.
- 2. Xanadu has the following arrangements in place under listing rule 3.19B with its directors to ensure that it is able to meet its disclosure obligations under listing rule 3.19A:
 - a) the Company and its directors are aware of their obligations under the listing rules including listing rules 3.19A and 3.19B; and
 - b) in accordance with listing rule 3.19B and Guidance Note 22, Xanadu has entered into Disclosure of Director's Interests Agreements with each of its directors when they are appointed to the Xanadu Board, which are regularly reviewed and formally updated at each meeting of the Board.
- 3. Xanadu confirms that following this incident, the Company has reviewed its processes and believes that its disclosure arrangements are adequate and are being enforced and that this was an isolated incident which does not involve any substantive breach of the ASX Listing Rules.
