Appendix 4C Quarterly Cash Flow Report For the Quarter Ending 30 June 2018

FarmaForce Limited ("FarmaForce" or "Company") (ASX:FFC), a contract sales organisation offering innovative solutions to the Australian Pharmaceutical Industry, releases the following commentary in relation to its Appendix 4C report for the period ended 30 June 2018.

Commentary

FarmaForce continued its momentum of strong sales growth and margin enhancement into the fourth quarter of FY2018.

The key results are:

- Cash at the end of the quarter was \$576,883 (March 2018 : \$617,967).
- A year-on-year increase of 116% in receipts from customers for Q4 FY18 when compared to Q4 FY17 (Q4 FY18 \$2,847K; Q4 FY17: \$1,317K).
- A year-on-year increase of 96% in receipts from customers for the twelve months ended Q4 FY18 when compared to the Q4 FY17 (Q4 FY18 YTD \$8,091K; Q4 FY17 YTD \$4,129K).
- A year-on-year decline of 143% in net cash flows generated in operations for Q4 FY18 when compared to Q4 FY17 (Q4 FY18: \$30K used; Q4 FY17 \$70K generated).
- Operating net cash flow for the twelve months period ended Q4 FY18 increased by \$1,330K on Q4 FY17 (Q4 FY18 \$301K generated; Q4 FY17 \$1,029K used).
- FarmaForce continues to maintain a financial position of **zero external debt**.


