Completion of the acquisition of Zunos Technologies

Bigtincan Holdings Limited (ASX: BTH) ("Bigtincan") is pleased to announce that it has completed the acquisition of Zunos Technologies Pty Limited ACN 137 369 736 ("Zunos") announced to the market on 18 June 2018.

At completion a cash payment of \$3.25 million was made by Bigtincan. The balance of the purchase price (capped at a value of \$11 million) will be determined based on recurring revenue earned from the Zunos platform in FY19 and FY20.
