Investment Objectives

Company Overview

- To deliver total returns in excess of the Benchmark over each full investment cycle
- To provide capital growth over each full investment cycle
- Aim to pay fully franked dividends (at least annually)

Commentary

The Company's NTA decreased 0.7% over the month after all Portfolio expenses and Company costs including tax on realised gains. The S&P/ASX Small Ordinaries Accumulation Index declined 1.0%.

We continue to see two areas of the smaller companies market which appear over- valued: the larger end momentum style stocks and at the bottom end the "wannabe disruptors". We hold the view that the market resembles a "voting machine" in the short term but a "weighing machine" in the longer run. Cash flow valuations – which are central to our process – are more akin to using a weighing machine to determine value than the myriad of shorter term approaches. The Company had good performance from its holdings Technology One (TNE.ASX) and Mortgage Choice (MOC.ASX). The Company did not hold Afterpay (APT.ASX) which performed strongly in July largely because it doesn't meet our investment process.




