## Financial services law and governance expert joins board of Managed Accounts Holdings

The appointment of Pamela follows the recent appointment of Mark Pozzi as CFO and Lisa Ng as Business Development Manager. Based in Melbourne, Mark brings over 29 years' experience in finance and accounting with an extensive background in financial services software, including 10 years with IRESS. Lisa joined in late May and is responsible for driving sales across South Australian and Western Australian markets, based in Adelaide. She also brings extensive experience in financial services, having worked at a boutique financial planning firm, Deloitte, Zurich Investments and Centrepoint Alliance over the last 20 years.
