The capital raising comprised \$803,260 for 127,501,690 ordinary shares through the Share Purchase Plan (“Share Plan”) and in addition, the private placement (“Placement”) application on the same terms (\$0.0063 per share) as the Share Plan was received for \$673,338 for 106,879,096 shares in accordance Section 708 of the Corporations Act 2001. The capital raisings are to be used towards advancing its Charters Towers Gold Project and general working capital.

The Placement shares will be issued under the Company’s existing capacity to issue securities in accordance with ASX Listing Rules 7.1 and 7.1A.

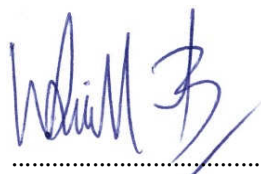
