David was most recently a Multi Asset Portfolio Manager at Schroders located in Sydney. Responsibilities included portfolio management, investment process development, investment strategy research and implementation - including the launch of the first active multi asset ETF (GROW.ASX), a US\$ version of the Real Return Fund (Schroder Global Target Return Fund) and development of direct active equity investment strategies (including Australian small caps and large caps) for the multi asset portfolios. As well as a member of the Australian Multi-Asset Portfolio Construction Group, he was a member of the Global Equity SIGMA research group on all Schroders global multi asset strategies.

Prior to joining the multi asset investment desk, David was a Senior Portfolio Manager in the Australian equity team having developed, launched and managed the Schroders Australian small and microcap equity funds from 2006 to 2013. These funds were both top quartile performers with pre-fee excess returns to the benchmark of 13.5% pa (Microcap) and 14.5% pa (Small Cap). During his management of these strategies, he achieved Winner Money Management | Lonsec Small Cap Fund Manager of the Year (2009), Finalist Morningstar Fund Manager of the Year Emerging Manager (2008).

Prior to Schroders, David began his investment career in 1997 as an equity research analyst at Ord Minnett (now JP Morgan), Merrill Lynch and Morgan Stanley covering various sectors including technology, healthcare, developers and contractors, resources and small companies.
