\$600,000 Placement

Invigor Group Limited (ASX: IVO) ("Invigor" or "the Company"), is pleased to confirm that it has agreed a \$600,000 placement commitment from a group of sophisticated investors including a substantial shareholder. The agreement is for a placement in two tranches of \$300,000 for 50 million ordinary shares issued at \$0.006.

The first instalment of \$300,000 has been received by the Company and an additional 50 million shares have been issued.

The second instalment of \$300,000 is subject to shareholder approval and is conditional on being taken up by October 31, 2018.
