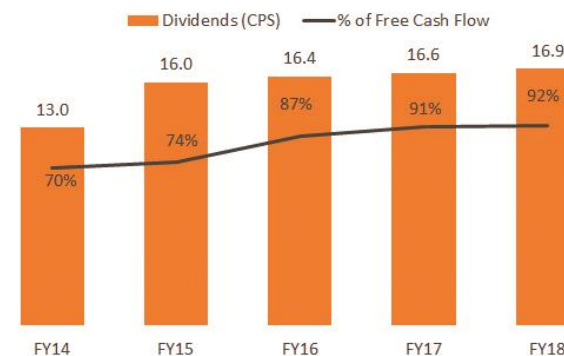

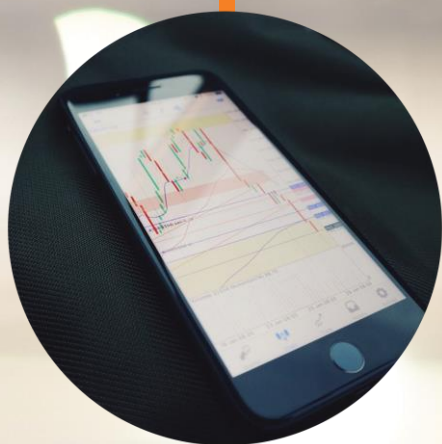

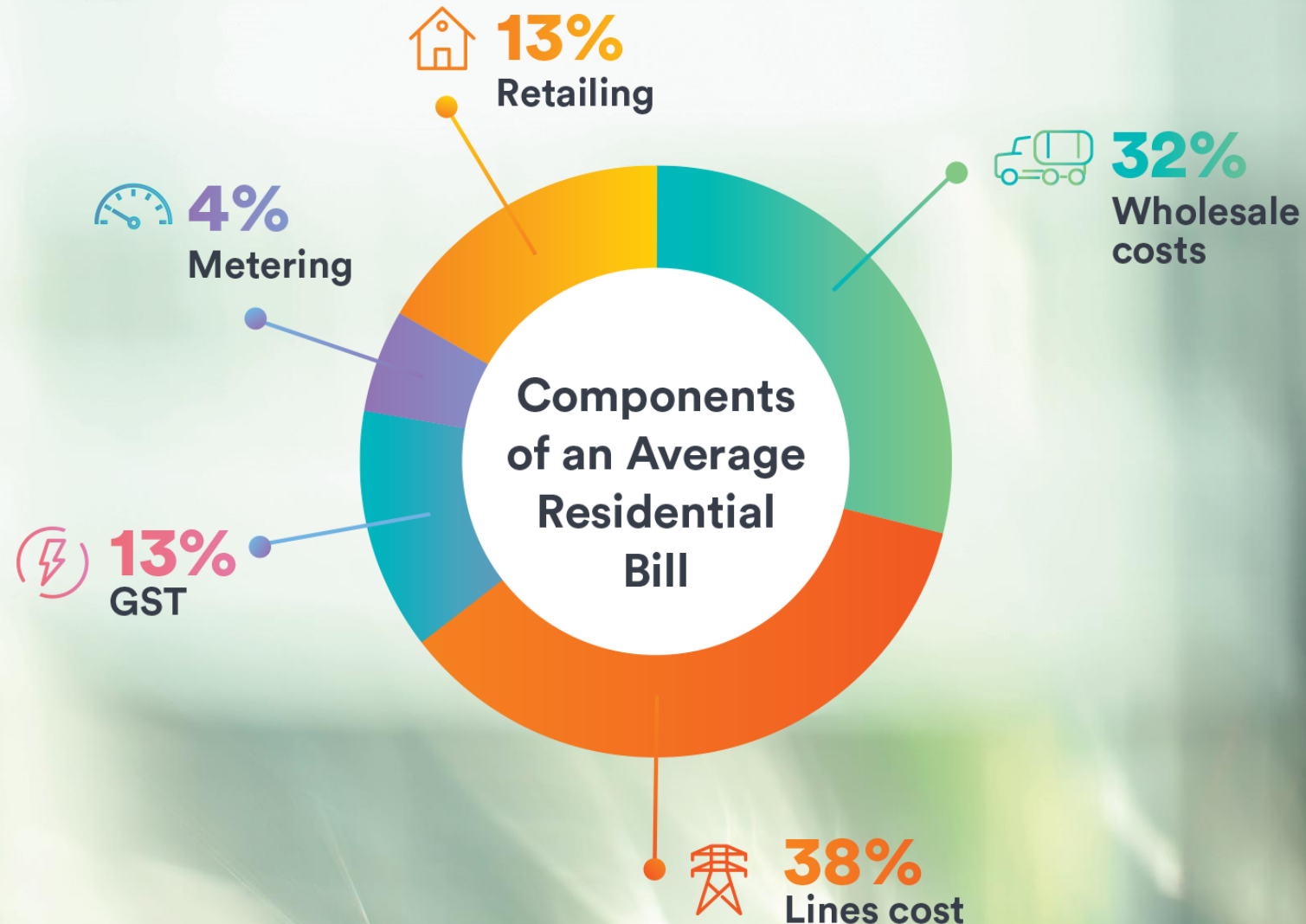
DIVIDEND CENTS PER SHARE & PAYOUT HISTORY



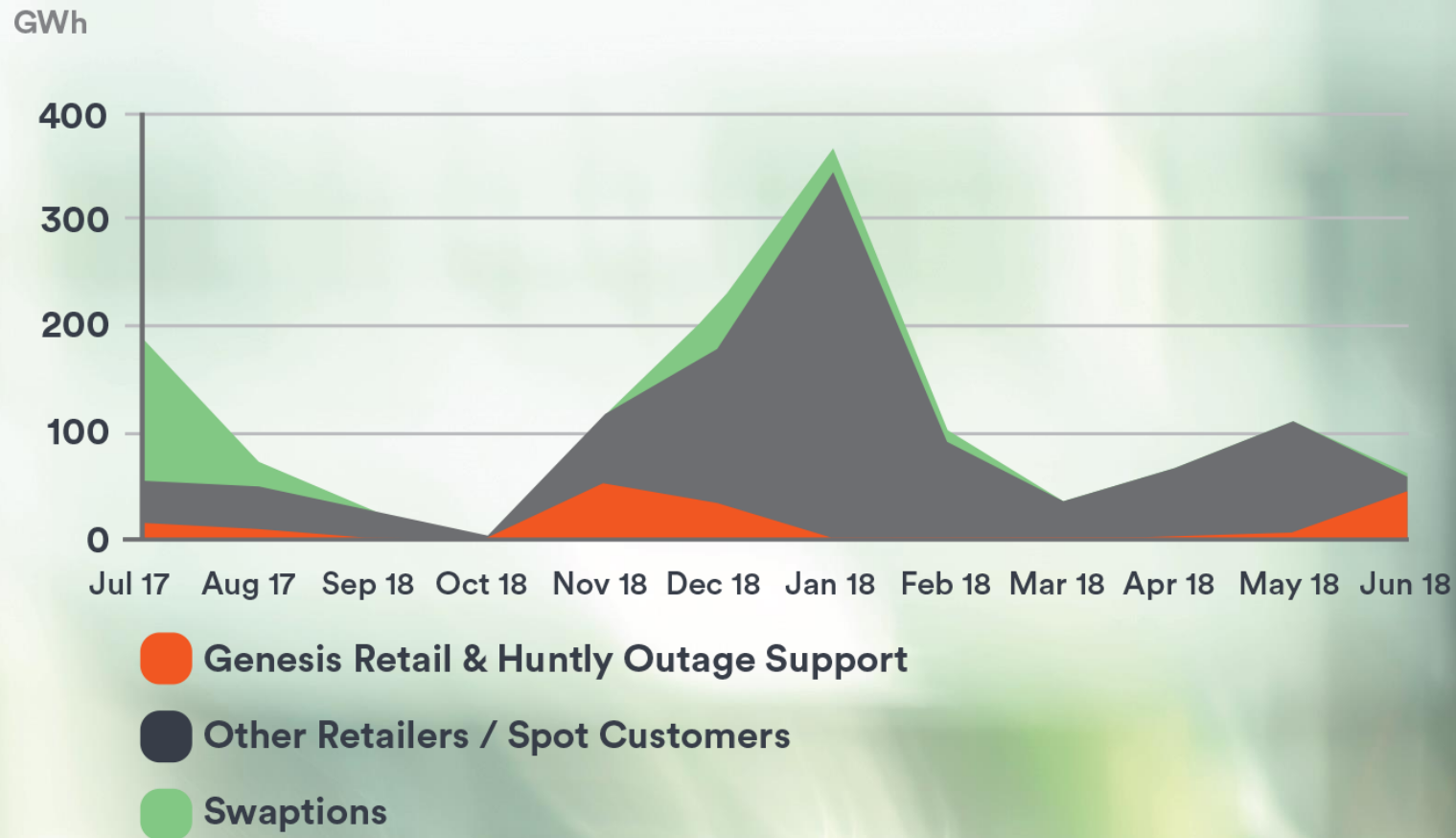

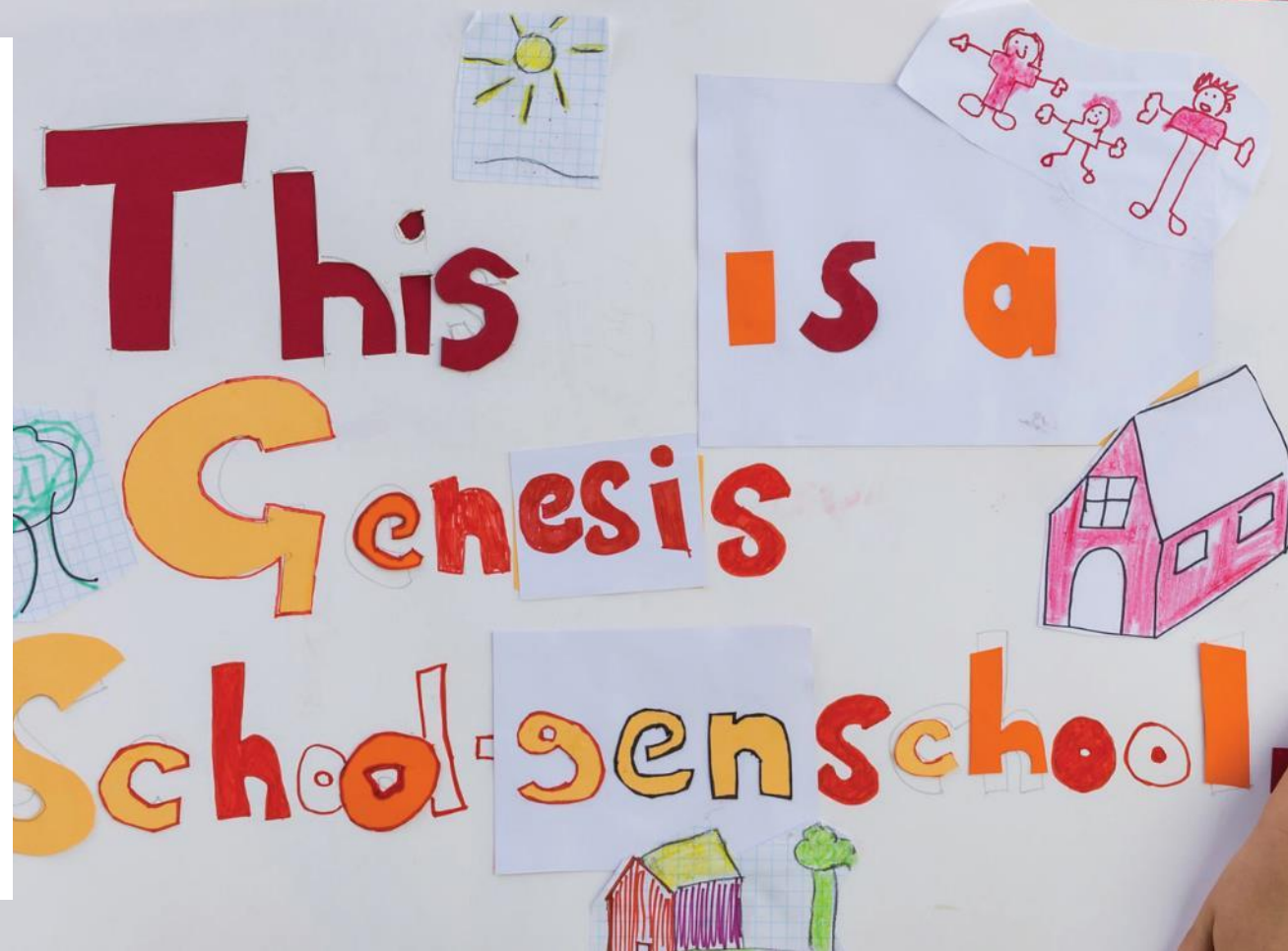
