## **Genesis Announces DRP Strike Price**

Genesis Energy Limited (NZX: GNE) advises that the issue price for shares issued in lieu of cash for the 2018 Final Dividend under its Dividend Reinvestment Plan (DRP) is \$2.4132 per share.

The issue price has been determined, in accordance with the DRP, as the volume weighted average sale price for all Genesis Energy shares sold on the NZX Main Board over a period of five business days starting on 4 October 2018, less a 2.5% discount.

Shareholders who have elected to participate in the DRP, will receive shares, instead of cash, in respect of the dividend payable on 19 October 2018.

The new shares will rank pari passu with existing shares on issue as at the date of their issue.
