Trade Finance Loan Book & Compliance as at 30 September 2018

In accordance with the Corporate Bond Issue Information Memorandums released to the ASX on 18 May 2015, CML Group (ASX code: CGR) wish to advise that as at 30 September 2018 it was compliant with all Financial Covenants contained within the Memorandums. The calculations are tabled below.

The purpose of this release is to confirm compliance with Corporate Bond Covenants, which is now a small component of CML's funding pool and should not be relied upon as an indicator of business volume or overall performance.

At the end of September 2018 CML had a trade finance loan book funded by Corporate Bonds of over \$33.0m (August 2018: \$42.7m), of which it had supplied actual funding of \$24.6m (August 2018: \$28.5m). This represents a Loan to Value ratio of 74.5% (August 2018: 66.8%).

Please note all Financial Covenant definitions are contained in the Information Memorandum released to the ASX on 18 May 2015.

Determination Date Statement Summary

1. We refer to the Conditions of the Bond. This is a Determination Date Statement as referred to in Condition 5.2(b) ("Financial Covenants"). Terms used in the Condition shall have the same meaning in this Determination Date Statement unless given a different meaning in this statement.
