NTA update

The estimated unaudited net tangible asset value before withholding tax on unpaid distributions at 30 September 2018 was \$1.79¹ per unit (31 August 2018 was \$1.79¹ per unit).

The Fund is a long-term investor and seeks to make investments in a tax-effective manner. If tax at 21% on estimated underlying investment values were to be recognised, the estimated unaudited net asset backing after tax as at 30 September 2018 would be \$1.78¹ per unit.

Fund update

Capital called

At 30 September 2018, US Select Private Opportunities Fund, L.P. (**LP**) has called US\$68.5 million (or 98.5% of capital committed). The Fund's proportionate share is approximately US\$58.6 million (an 85.5% share).

Drawdowns

During the month, the LP did not receive any drawdown requests.

At 30 September 2018, net drawdown requests from underlying investments were approximately US\$66.6 million (or 95.3% of total funds committed by the LP).
