An ERP System incorporates the entire business of an organisation including supply chain management, manufacturing resource planning, human resource management, customer relationship management and financial management.



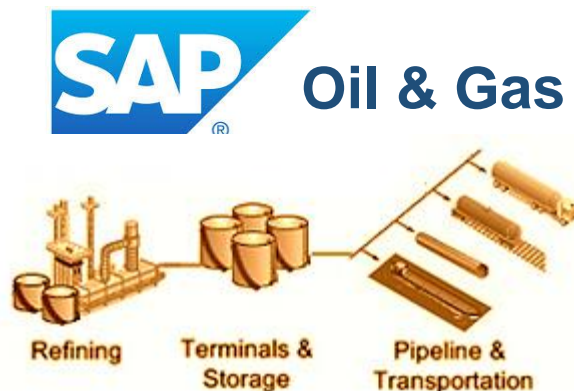
