Following the end of the quarter, the Company received an R&D Tax Incentive refund of \$1.07 million for the 2017/18 financial year (see ASX announcement dated 15 October 2018). In addition, the Company has entered into an Option Underwriting agreement to underwrite any shortfall arising from 78,429,130 listed options exercisable at \$0.06, with an expiry date of 30 November 2018. This will ensure that approximately \$4.7million will be added to Company's balance sheet (see ASX announcement dated 17 October 2018).
