The Net Cash Flow from operating activities for the quarter ending 30 September 2018 was \$(405,000). The cash receipts increased by over 100% (as compared to the previous 6 months - \$190,000) to \$200,000 via revenue generated from advisory mandate fees.

The Company will continue to fund its working capital requirements on an ongoing basis from fees generated from advisory mandates, the sale of existing investments and via a combination of equity and/or debt raisings.
