

## **Cannindah Bioceuticals Distribution Pty Ltd Executes Annabis Hemp Exclusive Business and Marketing Partnership Agreement**

Cannindah Resources Limited, via its wholly owned subsidiary Cannindah Bioceutical Distribution Pty Ltd (CBD), has now executed the agreement outlined in the recent quarterly report with Annabis Hemp. The agreement provides CBD the exclusive right to the sale and marketing of the Annabis Hemp products within Australia. The agreement is only subject to the packaging and products being compliant with Australian regulations, which is currently being worked on. While products derived from hemp seed oil are not illegal in Australia, there are certain regulations that still need to be complied with. The company will initially be managed by existing executive staff, with additional sales staff added as required.

Annabis is a natural cosmetics company based in the Czech Republic. The company deals with research, development, manufacture, and production of high-quality hemp products and food supplements. Annabis products are based on many years' experience and long-lasting relationships with cosmetics experts. Their customers use hemp products for a wide range of needs with outstanding results. High specialisation, professionalism and an intense focus on customers have enabled dynamic development of the company and a place among market leaders. An integral part of the Annabis business is minimising impacts on the environment. They do so by observing regulations concerned with environmental protection and by the implementation of consumption precautions to minimise use of energy and raw materials while reducing waste.

As discussed in the recent quarterly, the company did not purchase this right from Annabis. The agreement comes from months of discussion with Annabis executives and due diligence completed by Cannindah's Executive Chairman in consultation with the board. Staff will now focus on obtaining distribution channels within Australia in the health food and retail cosmetics space. Once we have satisfied Australian compliance requirements, we will then focus on growing the Annabis brand presence within Australia.

Cannindah Resources Limited as the parent company remains focussed on delivering outcomes in the Piccadilly gold project, which remains a highly prospective significant gold target in North Queensland. We are currently working through ground based geological survey planning, which we hope to commence in the immediate future, along with the finalisation of plans to commence drilling the target.
