Fairfax Media Limited to be removed from the S&P/ASX 200 Index

SYDNEY, NOVEMBER 21, 2018: S&P Dow Jones Indices announced today that it will remove Fairfax Media Limited (XASX: FXJ) from the S&P/ASX 200, subject to final court approval of the scheme of arrangement whereby the company will merge with Nine Entertainment Co. Holdings Limited (XASX: NEC).

S&P Dow Jones will remove Fairfax Media Limited from the S&P/ASX 200 effective at the open of trading on November 29, 2018. Fairfax Media Limited will not be replaced in the S&P/ASX 200 as the index currently carries an additional constituent as a result of the recent spin-off of Coles Group Limited (XASX: COL) from Wesfarmers Limited (XASX: WES).
