NEW COMMISSIONS EIGHT PLANTS IN NORTH CAROLINA AND OREGON

On Thursday 15 November 2018 New Energy Solar¹ (**NEW**) celebrated the completion of construction and commissioning of its eight newest solar plants in North Carolina and Oregon² at an event at NEW's 7.2 megawatt (**MW**_{DC}) County Home solar plant in Rockingham, North Carolina.

The event was hosted by NEW and project developer Cypress Creek Renewables (CCR). NEW acquired County Home and the seven other projects from CCR in December 2017 and CCR will now provide site operations, maintenance and monitoring services. With the completion of construction, these plants will add 55.6 MW_{DC} of emissions-free generation capacity to NEW's portfolio.

Senator Tom McInnis, who attended the event, said, "Solar is a significant and growing sector in North Carolina and Richmond County is proud to be a part of this success story. I applaud New Energy Solar and Cypress Creek on the County Home solar project, which will provide clean energy for decades to come and contribute to our local economy, providing revenue that will go to schools, the fire district and other important county services."

Along with representatives from NEW and Cypress Creek, the event was attended by solar industry participants as well as representatives from Rockingham County and US Bank, who provided tax equity financing for the project's construction.

Greg Gebhardt, CCR's Director of Community and Government Affairs, said, "We're thrilled to cut the ribbon today on North Carolina's newest solar farm. Cypress Creek is driven by the belief that solar makes our world cleaner and healthier. As the operator for County Home solar farm, we take great pride in our investment in rural North Carolina and look forward to continuing to be a part of the community."

The eight plants are expected to generate about 80,000 megawatts of electricity annually, enough electricity to power over 6,400 homes and displacing more than 61,000 tonnes of CO₂ emissions, the equivalent of removing more than 13,000 cars from the road.

County Home will sell 100% of its output to Duke Energy Progress under a 15-year power purchase agreement.

NEW Asset Manager, Paul Whitacre, said at the ceremony, "This plant is an example of solar energy becoming part of mainstream infrastructure investments – meeting not just the goals of investors to earn a return, but offsetting carbon emissions, helping utilities to reach their environmental targets, and creating new jobs in local communities."
