證券持有人所提供的個人資料如有任何錯誤,須立即通知本公司及香港證券登記處。

## 2. 資料用途

證券持有人的個人資料可以任何方式使用、持有處理及/或保存,以作下列用途:

- 處理 閣下的申請及退款支票(如適用)、核實 是否符合本申請表格及招股章程載列的條款和 申請手續以及公佈香港發售股份的分配結果;
- 遵守香港及其他地區的適用法律及法規;
- 以證券持有人(包括香港結算代理人(如適用))的名義登記新發行證券或轉讓或受讓證券;
- 存置或更新本公司證券持有人的名册;
- 核實證券持有人的身份;
- 確定本公司證券持有人的受益權利,例如股息、供股和紅股等;
- 分發本公司及其附屬公司的通訊資料;
- 編製統計數據和證券持有人資料;
- 透過報章公佈或其他方式披露成功申請人士之 身份;
- 披露有關資料以便就權益索償;及
- 與上述有關的任何其他附帶或相關目的及/或 使本公司及香港證券登記處能履行對證券持有 人及/或監管機構承擔的責任及/或證券持有 人不時同意的任何其他目的。

### 3. 轉交個人資料

- 本公司委任的代理,例如財務顧問、收款銀行 和主要海外股份過戶登記處;
- (如證券申請人要求將證券存於中央結算系統) 香港結算或香港結算代理人,彼等將會就中央 結算系統的運作使用有關個人資料;
- 向本公司或香港證券登記處提供與其各自業務 營運有關的行政、電訊、電腦、付款或其他服 務的任何代理、承包商或第三方服務供應商;
- 聯交所、證監會及任何其他法定監管機關或政 府部門或其他法例、規則或法規所規定者;及
- 證券持有人與其進行或擬進行交易的任何人士 或機構、例如彼等的銀行、律師、會計師或股 票經紀等

## 4. 個人資料的保留
