Ardent Leisure Group Limited – Admission and Commencement of Official Quotation

Description

On 10 October 2018, Ardent Leisure Group (the "Group") announced that it was convening a meeting to seek securityholder approval for the corporatisation of the Group, by replacing the Group with a newly established company, Ardent Leisure Group Limited (the "Company"), that would become the single head entity of the Group in place of the current stapled structure (the "Corporatisation").

The Group also announced that the Supreme Court of New South Wales ("Supreme Court") had made orders approving the despatch of the securityholder booklet in relation to the Corporatisation, and that meetings of the Group's securityholders be convened to consider and vote on the Corporatisation.

Under the Corporatisation, and pursuant to the schemes of arrangement between Group securityholders and Ardent Leisure Limited and the trust scheme of the Ardent Leisure Trust (the "Schemes"), the Group's security holders will receive one fully paid ordinary share in the Company for each stapled security they hold in the Group.

On 20 November 2018, the Group's securityholders approved, amongst other things, the Corporatisation.

On 28 November 2018, the Group announced that the Supreme Court had made orders approving the Schemes and given the judicial advice. On 29 November 2018, the Group announced that a copy of the Court's orders and the judicial advice have been lodged with the Australian Securities and Investments Commission and that the Schemes had become effective.

On 30 November 2018, the Company is expected to confirm that all the conditions of the Corporatisation have been satisfied.

The Company is expected to be admitted to the official list of ASX Limited ("ASX") on Friday, 30 November 2018.

Official quotation of the Company's ordinary fully paid shares is expected to commence on a deferred settlement basis at 11:00AM AEDT on Friday, 30 November 2018.
