Change in relevant interest: As notified on 3 December 2018, in accordance with the implementation agreement disclosed on 15 August 2018 (**Implementation Agreement**) the unincorporated joint venture between Mercury NZ Limited (**MCY**) and Infratil for the purposes of

a proposed full takeover of TLT (**Offer**) terminated at the end of 30 November 2018 on close of the offer.

For the purposes of section 278 of the Financial Markets Conduct Act 2013, the substantial product holders named in this notice advise that there has been a change in the nature of their relevant interests in TLT resulting from Infratil becoming the registered holder of the final 63,301 shares accepted into the Offer before the closing date for which payment has now been sent.
