Amendment to Appendix 3B

On 14 December 2018, Elders Limited (ASX:ELD) lodged an Appendix 3B to the ASX. That Appendix 3B erroneously stated the number of securities to be issued as 4,863,324 (being the total securities participating in the Elders Dividend Reinvestment Plan, not the total securities that were to be allotted under the same Plan).

Attached is an amendment to the Appendix 3B lodged on 14 December 2018, which now reflects the correct number of securities that should have been issued and allotted under the Elders Dividend Reinvestment Plan being 61,609 fully paid ordinary shares. The revised number of all securities quoted on ASX is also contained in section 8 of the attached.

All other content disclosed in the Appendix 3B lodged on 14 December 2018 remain unchanged.
