17 January 2019 – N1 Holdings Limited (ASX: N1H or the "Company") presents this Appendix 4C quarterly report for the period 1 October 2018 to 31 December 2018.

N1 is pleased to announce a record quarter of cash receipts, notably due to growth in commercial lending. The management of N1 acknowledges the challenging property market and tightening lending environment, and has diversified N1's revenue streams as outlined in the 2016 IPO prospectus.

A summary of the latest quarter's cash flow performance is provided below.

- 1. Record cash receipts from customers of \$1.209m for the quarter.
- 2. Growth of cash receipts from customers by 35.3% compared to the previous period (September 2018 quarter), from \$893k to \$1.209m.
- 3. Growth of cash receipts from customers by 25.4% compared to the same period in the previous year (December 2017 quarter), from \$964k to \$1.209m.
- 4. Operational expenses, excluding net cash from commercial lending, remains consistent.
- 5. The Company continues to raise funds for commercial lending purposes.
