**re: Notices of change of interests of substantial holder – Duxton Vineyards Pty Ltd & Duxton Vineyards Water Pty Ltd**

Please find enclosed 6 form 604 - 'Notice of change in interests of substantial holder' for the above two associated companies required to bring their holder's interest position up to date.

The Duxton Vineyards Group ('**DV Group**'), including the two entities in these notices above, is in the process of restructuring and as part of the process the DV group came under the Duxton Capital (Australia) Pty Ltd ('**DCA**') AFSL and following the appointment, DCA reviewed the DV Group's submitted substantial interest notices in relation to Duxton Water Ltd ('**the Company**') and it became apparent that due to an administrative oversight by the DV Group that the notices attached to update the position had not been prepared and lodged.

The details of each change is detailed below and its noted that while the shares held by the DV Group in the Company only increased by less than 1% under two of the transactions, what was overlooked was the fact the voting interest was diluted by virtue of the numbers of shares taken up by other shareholders, relative to the DV group, during the period since the last notice under the Company's Dividend Reinvestment Plan ('**DRP**'), in the exercising of the Listed Company options which expired 31 May 2018, and then the Accelerated Entitlement Offering and Retail Entitlement Offering completed in late November 2018.

It is noted that as part of the Accelerated Entitlement Offering and Retail Entitlement Offering the market was informed of the non-participation of the DV group and the resultant dilutionary impact.

## Details of Notifications Attached Updates Changes

**1      *14 March 2018 – Exercise of Company Listed Options by other shareholders***

The DV Group had not exercised their options at this date, however what was overlooked was the dilutionary impact on its holding by virtue of other unrelated shareholders exercising their options, which resulted in the DV Group's voting percentage in the Company reducing from the previously notified 46.69% to 45.52%.

**2      *22 May 2018 - Exercise of Company's Listed Options***

Duxton Vineyards Pty Ltd exercised 536,680 31 May 2018 expiring Listed Options in the Company for \$1.10 which as at the date of exercising, due to other options exercised by other unrelated shareholders, saw its voting percentage reduce from 45.52% to 44.56%.

**3      *16 June 2018 – Completion of the 31 May 18 Listed Options Exercise***

On 14 June 2018 the Company confirmed to the market the final details of the total shares issued from the 31 May 2018 Listed Options being exercised. Based on the total number of new shares issued, the DV Group's voting percentage was diluted from 44.56% to 37.72%.

**4      *14 September 2018 – Participation in the Company's DRP***

The DV group participated in the company DRP, in full, in relation to the 14 September 2018 Company dividend. As such its holding in the Company increased by 639,187 shares and its voting percentage increased marginally from 37.72% to 38.12%

**5      *24 October 2018 – Non-participation in the Company's Accelerated Entitlement Offering***

As disclosed as part of the offer documents, the DV Group did not participate in the Company's Accelerated Entitlement Offering. By virtue of the new capital raised by the Company under the offer from other unrelated shareholders, the DV Group's interest was diluted from 38.12% to the current 35.19%.

**6      *23 November 2018 – Non-participation in the Company's Retail Entitlement Offering***

As disclosed as part of the offer documents, the DV Group did not participate in the Company's Retail Entitlement Offering. By virtue of the new capital raised by the Company under the offer from other unrelated shareholders, the DV Group's interest was diluted from 35.19% to the current 31.70%.
