Director Resignation

The Board of directors of Centrepoint Alliance Limited (ASX:CAF) ('Centrepoint') advises that Andrea Slattery has resigned as a non-executive director, effective 31 January 2019.

Andrea, who was appointed to the Board in November 2018, is stepping down after accepting a non-executive Board position at AMP Limited effective from 15 February 2019.

Andrea says: "It's with considerable regret that I must resign my Board position at Centrepoint, as my appointment to the AMP Limited Board prevents me from being a director of both companies.

"In my short time on the Board I have been greatly impressed with how the company under chairman Alan Fisher and CEO Angus Benbow has set a strategy for growth that I am sure will deliver excellent results for advisers, their clients, staff and shareholders.

"Centrepoint's business model of developing and supporting advisers by providing cutting edge technology, services, education, training and integrated compliance monitoring to ensure they can fully meet client expectations is tailor made for a post Royal Commission financial services world.

"I wish Alan, Angus, and the team at Centrepoint all the best for the future knowing that they are pursuing the right path for long-term success."

Chairman, Alan Fisher, said, "Andrea leaves the Board of Centrepoint on excellent terms and we wish her every success in her new role. Although a replacement for Andrea will be recruited, in the meantime I am pleased to advise that the Board continues to be committed to the Company's strategy announced in August 2018, Strategic Refresh.

"CEO, Angus Benbow, has made substantial progress on delivering the strategy. Centrepoint is dedicated to providing a range of industry leading services designed to put financial advisers in the best possible position to satisfy their clients' needs and to meet the community's expectations of trust and competence.

"The Board, together with Angus, believes this strategy will produce the optimal, most sustainable long-term return for shareholders."
