NEW ENERGY SOLAR (ASX: NEW) **UNAUDITED NET ASSET VALUE AS AT 8 FEBRUARY 2019**

New Energy Solar's¹ weekly estimated unaudited net asset value (**NAV**) as at 8 February 2019 was A\$1.55 per stapled security.

New Energy Solar's directors have elected to make this disclosure to the market to provide securityholders with additional information about changes in the estimated NAV of their stapled securities due to movements in the AUD:USD foreign exchange rate.

This weekly unaudited NAV estimate has been calculated by reference to New Energy Solar's most recently published audited NAV (being A\$1.53 per stapled security as at 30 June 2018, which applied an AUD:USD foreign exchange rate of 0.7405), adjusting for changes in the AUD:USD foreign exchange rate and the number of stapled securities on issue since that date, and deducting the 4.00c distribution per stapled security declared in November 2018. The applicable AUD:USD foreign exchange rate applied in calculating the estimated unaudited NAV as at 8 February 2019 was 0.7088.

Securityholders should note that New Energy Solar's stapled securities have traded on an ex-distribution basis since 28 December 2018 in relation to the 4.00c distribution per stapled security announced on 20 November 2018.

New Energy Solar is in the process of reviewing and updating the fair value of its investments as part of the 2018 annual financial report to be released during February 2019. Accordingly, NEW's unaudited NAV estimate noted above does not take into account any potential changes to the value of New Energy Solar's investments that might arise from the revaluation exercise.
