The weekly estimated unaudited net asset value before withholding tax on unpaid distributions as at 1 March 2019 was \$1.57\* per unit.

The Fund is a long-term investor and does not intend to dispose of its total portfolio. If estimated tax on unrealised portfolio gains or losses were recognised, the weekly estimated unaudited post tax net asset value before withholding tax on unpaid distributions as at 1 March 2019 would be \$1.37\*.
