SECTION 708A CLEANSING NOTICE

This notice is given by Chesser Resources Limited (**ASX: CHZ**) as required by section 708(5)(e) of the Corporations Act 2001 (Cth) (**Corporations Act**).

Chesser Resources Limited ("Chesser") advises that effective 15 March 2019 it issued the following securities as announced in an Appendix 3B dated 15 March 2019:

- (a) 2,920,000 shares being issued at \$0.038 per share to Directors pursuant to shareholder approvals received at a general meeting of the Company's shareholders on 26 February 2019.
- (b) 600,000 shares being issue as loan funded shares pursuant to the Managing Director's contract. The loan funded shares were issued at an issue price of \$0.05 per share and received shareholder at a general meeting of the Company's shareholders on 26 February 2019.
- (c) 175,200 shares issued in lieu of cash settlement of brokerage fees payable in relation to the issue of shares referred to in (a) above.
- (d) 5,500,000 Unlisted Options with an expiry date of 30 November 2021 and an exercise price of \$0.05 per share subject to vesting conditions pursuant to shareholder approvals received at a general meeting of the Company's shareholders on 26 February 2019.
- (e) 1,500,000 Unlisted Options with an expiry date of 1 December 2022 and an exercise price of \$0.05 per share subject to vesting conditions pursuant to shareholder approvals received at a general meeting of the Company's shareholders on 26 February 2019.

- 1. The equity securities were issued without disclosure to investors under Part 6D.2 of the Corporations Act.
- 2. This notice is being given under section 708A(5)(e) of the Corporations Act.

 - (a) The provisions of Chapter 2M of the Act as they apply to Chesser; and
 - (b) Section 674 of the Corporations Act.
