Plato Australian Shares Income Fund (Managed Risk) (ARSN 126 577 820)

Notice under section 601NC of the Corporations Act 2001 (Cth) (Corporations Act)

Dear Investor,

This letter is intended to provide you, as a member in the Plato Australian Shares Income Fund (Managed Risk) (the **Fund**), with information about the proposed closure of the Fund and to provide you with sufficient time to assess your individual circumstances.

Pinnacle Fund Services Limited (the **Responsible Entity**) has reviewed the strategic options available to the Fund and concluded that the Fund cannot accomplish its investment objectives and strategy as it is unlikely that it will achieve the necessary scale to sustain the costs associated with operating the Fund. Accordingly, the Responsible Entity has determined that it is in the best interests of the members to wind up the Fund.

The Responsible Entity is obliged to inform members of the Responsible Entity's intention to commence winding up the Fund. Unless a meeting is called by members within 28 days of the date of this notice and determine otherwise, the Responsible Entity will commence winding up the Fund on 24 May 2019 in accordance with section 601NC(3) of the Corporations Act.

The members of the Fund are entitled to take action under Division 1 of Part 2G.4 of the Corporations Act to have a meeting called to consider and vote on any extraordinary resolution the members propose in relation to the winding up of the Fund. A meeting may be called by:

- members representing at least 5% of the units on issue giving a written request to the Responsible Entity in accordance with section 252B of the Corporations Act;
- members representing at least 5% of the units on issue calling and arranging a meeting of members themselves in accordance with section 252D of the Corporations Act; or
- a court on application of a member entitled to vote if it is impracticable to call the meeting in any other way under section 252E of the Corporations Act.

If a meeting is called, the required steps and timetable for the winding up may vary and will depend on the nature of the extraordinary resolution(s) members propose about the winding up and whether it is passed.

Should the members not call a meeting as described above, the Responsible Entity is permitted to wind up the Fund thereafter.

Investment strategy exposure

There will be no changes to the Fund's investment strategy, approach, or objective in the process of winding up the Fund. Note that applications for new units in the Fund will not be accepted from the date of this notice.

Plato Investment Management Limited ABN 77 120 730 136 AFSL 504616 (**Plato**), the investment manager of the Fund, also manages the Plato Australian Shares Income Fund which offers exposure to a similar investment strategy and objective to the Fund.

What do you need to do?

Switching your investment

You may switch your investment to an alternative investment opportunity managed by Plato by completing the enclosed "Investment Switch Form". Please note in the event you choose to switch your investment into another Plato Fund, there will be no associated transaction costs.

Please see enclosed flyer outlining other investment options that may be of interest to you.

Withdrawals

Members are able to redeem at any time between the date of this notice and the proposed winding up commencement date, as long as the Responsible Entity determines that redemption does not adversely impact the position of the remaining members. Under such circumstances, the Responsible Entity may delay the processing of the withdrawal request or instruct a special distribution to facilitate the redemption.

Holding your investment

Alternatively, you may hold onto your investment until the assets of the Fund are fully realised at which time the proceeds (less any outstanding expenses, costs and disbursements of the Fund are paid) will be distributed to you and all other remaining investors.

Changes to the Plato Australian Shares Income Fund (Managed Risk)

Pinnacle Fund Services Limited (**Pinnacle**), as responsible entity of the Plato Australian Shares Income Fund (Managed Risk) ARSN 126 577 820 (**Fund**), has written to notify you that a decision has been taken to wind-up the Fund.

As an investor in the Fund, actions available to you are as follows:

- 1. Switch your investment to an alternative investment opportunity managed by Plato Investment Management Limited ABN 77 120 730 136 AFSL 504616 (**Plato**, the investment manager of the Fund);
- 2. Redeem your investment before the Fund is wound-up; or
- 3. Do nothing, in which case we will return your monies to you upon completion of the wind-up process.

Plato Investment Management Limited

In addition to managing the Fund, Plato is also the investment manager of a number of investment strategies, and information on these can be found on Plato's website, www.plato.com.au/retail-funds/. Please note in the event you choose to switch your investment into another Plato Fund, there will be no associated transaction costs.

The Fund invests up to 100% of its value in the Plato Australian Share Income Fund ARSN 152 590 157 (Underlying Fund), with the residual investments in cash and interest rate futures to manage portfolio risk. The differences between the Fund and the Underlying Fund are outlined below.
