### Smiles Inclusive Limited: Second notice of requisition under 249D

Smiles Inclusive Limited (ASX:**SIL**) confirms receipt of a second notice requisitioning a shareholders' meeting pursuant to section 249D of the Corporations Act from shareholders holding more than 5% of the ordinary shares of the company (**Second Requisition**).

The Second Requisition was received after the close of the market on 28 March 2019 from Poltik Pty. Ltd (which is an entity associated with Mr Lev Mizikovsky) and Mr Jonathan Hamilton (both as trustee and in his personal capacity). Mr Mizikovsky holds a significant number of the Company's shares, and Mr Hamilton is associated with one of the Company's joint venture partners.

The Second Requisition (a copy of which is **enclosed** with this announcement) requests that the Company hold a general meeting to consider resolutions to remove Mr Mike Timoney and Mr David Herlihy as directors.

The Company intends to consider the resolutions set out in the Second Requisition at its general meeting to be held on 22 May 2019.
