Yancoal Australia Ltd - late lodgement of Appendix 3Y for Mr Fucun Wang

Yancoal Australia Ltd (ACN: 111 859 119) (the **Company**) refers to the Appendix 3Y Change of Director's Interest Notice for Mr Fucun Wang (the **Appendix 3Y**) appended to this document.

The late lodgement of the Appendix 3Y was due solely to an administrative oversight by the Company. The Company has now taken immediate steps to rectify this oversight by lodging the Appendix 3Y.

The Company had not appreciated the need to file the Appendix 3Y while the performance rights granted to Mr Wang under the Company's Equity Incentive Plan remained subject to vesting conditions that remained unsatisfied. It is also noted that the Company had previously disclosed to ASX in its Remuneration Report for FY2018 (which was included in the Company's FY2018 Financial Accounts lodged with ASX on 26 February 2019) details of the performance rights to be granted to Mr Wang in relation to FY2018 (as adjusted).

The Company is satisfied that:

- each director of the Company is aware of ASX Listing Rule 3.19A and their obligations to provide all necessary information to the Company to enable the Company to meet its disclosure obligations; and
- b) it has the necessary reporting and notification policies implemented to ensure compliance with its disclosure obligations under the ASX Listing Rules.

The Company will endeavour to comply with its notification obligations in a prompt and timely manner henceforth.
