### NOTIFICATION PURSUANT TO SECTION 708A(5)(e) OF THE CORPORATIONS ACT 2001 (CTH)

This notice is given by the Company under section 708A(5)(e) of the Corporations Act 2001 (Cth) (Corporations Act) in relation to the issue of 62,050,000 Convertible Loan Notes on 15 April 2019 to Sophisticated and Professional Investors to provide working capital and to the Directors of the Company to provide working capital and in lieu of cash as remuneration for their roles as Directors.


