These transfers represent 50% of the total shares held by Claraville Station Pty Ltd and 2 King William St Pty Ltd in Duxton Broadacre Farms Ltd. Claraville Station Pty Ltd and 2 King William St Pty Ltd are 50% owned by Richard Magides, therefore the overall underlying shareholding (direct and indirect) of Richard Magides has not changed. The increase in the percentage of ownership of Richard Magides in Duxton Broadacre Farms Ltd is due to a reduction of the number of shares on issue.
