Re: Information under ASX Listing Rules 7.1A.4 and 3.10.5A

Re: Notification under section 708A(5)(e) of the Corporations Act 2001 ("the Act")

On 16 April 2019, Tlou Energy Limited (ASX:TOU) (the "**Company**") announced it raised BWP21.8 million (approximately AUD\$2.9 million or £1.6 million) (before costs) via a placement to sophisticated and institutional investors ("**Placement**").

The issue price of the securities, the VWAP calculation over the 15 trading days on which trades in the relevant securities were recorded preceding the date of issue or date of agreement to issue the securities under listing rule 7.1 and 7.1A, and the source of the VWAP calculation are detailed in the Appendix 3B lodged today.

The Placement is utilising the Company's capacity under ASX Listing Rules 7.1 and 7.1A. The Placement shares are being issued at \$0.10, which amount is approximately a 2% premium to the 15-day VWAP as calculated under LR 7.1A.3, of \$0.979 per shares, calculated as at close of market Monday 15 April 2019, as the trading price-volume data available on the ASX market for the Company's securities.

Due to the issue of the shares using the Company's placement capacity under ASX Listing Rule 7.1A, the Company provides the following information in accordance with ASX Listing Rule 3.10.5A.

- A) 28,911,534 ordinary shares will be issued under the Company's ASX Listing Rule 7.1A capacity. Existing shareholders have been diluted by approx. 6.86% following the Listing Rule 7.1A component of the Placement made today.

155,116 ordinary shares will be issued under the Company's ASX Listing Rule 7.1 capacity.

There are no other shares being issued at this time either under Listing Rule 7.1 A or Listing Rule 7.1 in addition to the 29,066,650 ordinary shares being issued under this Placement.

- B) The Company conducted the Placement rather than a pro-rata issue or other type of issue in which existing security holders would have been eligible to participate, as it was considered to be the quickest, most efficient and most certain method of raising funds in the current market.
- C) The Placement was not underwritten.
- D) The Company has paid to Motswedi Securities a success of 1.5% on the total amount raised under this Placement. In addition, the Company will miscellaneous expenses including listing fees and registry fees in connection with the Placement.

Notification under section 708A(5)(e) of the Corporations Act 2001 (“the Act”)

The Company confirms that it today has issued 29,066,650 new fully paid ordinary shares in the Company (“**New Shares**”) at an issue price of \$0.10 per New Share pursuant to the Placement.

The Corporations Act 2001 (“the Act”) restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A. By the Company giving this notice, the sale of the shares referred to in the Appendix 3B lodged today, will fall within the exemption in section 708A(5) of the Act.

The Company hereby issues a notice under section 708A(5)(e) of the Act that:

- (a) the New Shares, that have today been issued are part of a class of securities quoted on the Australian Securities Exchange;
- (b) the New Shares were issued without disclosure to investors under Part 6D.2 of the Act;
- (c) the Company, as at the date of this notice, has complied with:
 - (i) the provisions of Chapter 2M of the Act as they apply to the Company; and
 - (ii) Section 674 of the Act; and
- (d) as at the date of this notice, there is no ‘excluded information’ of the type referred to in sections 708A(7) and 708A(8) of the Act, to be disclosed under section 708A(6)(e) of the Act.
