In Q3 2017, a wholesale funding agreement was entered into structured around the purchase of \$50 million in Wisr originated loan assets. This became operational in October 2017. Wisr continues to make use of this facility for the funding of loan assets.

Also note that the company announced an equity capital raise on 28 March 2019 for which the first tranche of funds was received in April 2019. Refer to accompanying commentary for further detail.
