The Directors of Site Group International Limited ("Site", ASX:SIT) have released the Appendix 4C quarterly cash flow for the quarter ended 31 March 2019.

The results for the quarter saw revenues of \$6.5m and an EBITDA loss of \$1.7m which includes abnormals outlined below(unaudited). Operating cash flow for the quarter was an outflow of \$433k and the group has a closing cash balance of \$733k.

Consistent with previous years, the operating cash flow is impacted in the March Quarter due to the working capital impacts of the quieter seasonal training months of December through to February. This includes with continuing impact of customers postponing training with Site Skills Group until finalisation of the appeal process in the AAT. There has also been significant expenditure of operational resources and professional advisors (in excess of \$600k for the quarter) which continues to negatively impact the domestic results for the group.

The momentum in the overseas operations including the recently awarded contracts in the Kingdom of Saudi Arabia, announced in April, continues to drive new and repeat business internationally.
