## **AGUIA ANNOUNCES FILING OF NI 43-101 TECHNICAL REPORT FOR ANDRADE DEPOSIT**

**Sydney, Australia**, May 3, 2019 – Agua Resources Limited (“Agua” or the “Company”) (TSXV:AGRL, ASX:AGR) announces that following the release of a maiden Mineral Resource Statement for the Andrade Copper Project on March 18, 2019, a NI 43-101 Technical Report has been prepared and filed with the Canadian regulatory authorities.

The Technical Report was prepared using definition standards for mineral resources in accordance with both the 2012 edition of the ‘Australasian Code for Reporting of Exploration Results, Mineral Resources and Ore Reserves’ (JORC Code) and with Canadian Institute of Mining, Metallurgy and Petroleum (CIM) definitions as incorporated in National Instrument 43-101 – Standards of Disclosure for Mineral Projects of the Canadian Securities Administrators (“NI 43-101”). The JORC Code is the accepted reporting standard for the Australian Stock Exchange Limited (“ASX”).

The Technical Report, entitled Technical Report on the Andrade Deposit, State of Rio Grande do Sul, Brazil, was authored by Mr. John Makin, MAIG, a Senior Geologist at Roscoe Postle Associates Inc. Mr. Makin qualifies as a Competent Person as defined in the JORC Code and a Qualified Person as defined by NI 43-101. The Technical Report has been issued with a report date of May 2, 2019. The Technical Report is consistent with the disclosure made by Agua in its news release of March 18, 2019.
